ethics is not necessarily about acting in accordance with one's feelings as sometimes a person's feelings about a particular issue may lead them to act in a way that is unethical.

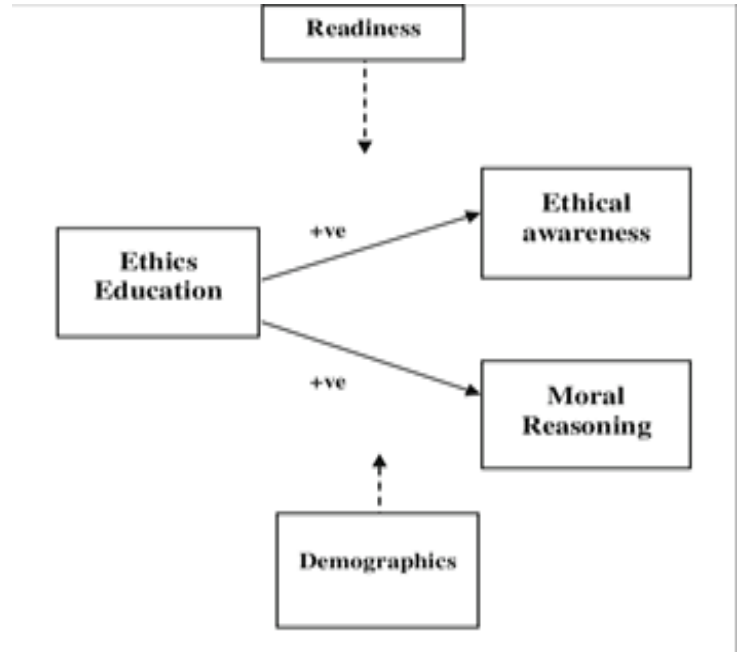
